

What is a Teleclass?

It's simply a phone call that connects participants for a continuing education class without the inconvenience, time, or expense of traveling to a central site to attend class. Participants can call from their office, home, or any other quiet place that there is a telephone. The process is simple. Participants merely dial the toll-free "teleconference number" for the class and they are automatically connected with up to 25 other callers.

How Does It Work?

Several days before the teleclass you will receive an email or fax with the toll-free phone number. You will also receive class handouts with this email or fax. On the appointed date and time of your selected course you dial into the teleclass line. You are instantly *connected* with the rest of the class.

How Will I Receive my Certificate of Completion?

Certificates of Completion are emailed within 2 working days of the completion of the teleclass to those who have provided an email address. Certificates of Completion will be mailed will be sent within 5 working days to those who receive handouts by fax.

Cancellation Policy

A full refund will be returned if cancellation is 7 days prior to the teleclass date.

Replacement Certificates

There will be a \$25 fee for replacement certificates or to verify attendance at a seminar. Requests for replacement certificates or verification of attendance must be made in writing. Requests will be processed within 14 days.
